Policy Statement

The "solid, liquid, and e-waste principle" will be used by the college to its delivery-based waste management system. The College will adopt 5Rs-to reduce, reuse, recycle, refuse & rethink as waste management approach. The management of solid and liquid waste produced on campus must adhere to the standards and guidelines outlined in the Municipal Wastes (Management Handling) Rules, 1999. These rules were released on September 27, 1999, through a government of India notification in the Ministry of Environment and Forest with the number S.O.783 (E). The notification was published in the Indian Gazette, Part II, sub-section (ii). Everyone who produces, stores, or disposes of hazardous, radioactive, or chemical waste must abide by the rules set forth by national and international environmental protection laws.

- To minimize generation of waste.
- To ensure segregation of waste at the source.
- To ensure the effective delivery of waste to the municipality.
- To maintain minimum plastic use on campus.
- To create awareness among all the stakeholders about waste management.
- To install waste collection units at various locations in the campus.
- To ensure a holistic approach of waste management in the campus.

1. Solid Waste Management:
